CALL TO ORDER

Mayor Jeff Holt called a recessed meeting of the Pine Level Board of Commissioners back into session at 3:20 p.m. on Tuesday, October 12, 2010 at the Pine Level Town Hall.

BID OPENING

The recessed session was held to open bids on the renovation of the building at 306 East Brown Street as a new town hall facility. Several contractors were in attendance, as were Dan Simmons, architect Ryland Edwards, Rhonda Toppings with USDA, and the town clerk. Mayor Holt welcomed everyone to the bid opening; acceptance of bids was cut off at 3:00 p.m. Mr. Edwards opened the bids and called out a figure for a base bid plus an alternate bid. Ms. Toppings said she would need a copy of the bid tabulation and a letter of recommendation from the town. She said the bid would have to be approved by the USDA engineer. Mr. Simmons said interim financing would have to be approved by the LGC and they meet every month on the first Tuesday of the month. He hopes to have the town's packet before them on December 7th. He said the town could award the bid contingent upon approval by the LGC. He said the initial budget was \$825,000 with the final \$100,000 being grant funds.
