



**AN ORDINANCE DECLARING SPEED LIMITS ON CERTAIN STREETS WHICH ARE LOCATED WITHIN THE TOWN OF PINE LEVEL AND ARE NOT A PART OF THE STATE HIGHWAY SYSTEM**

**WHEREAS**, pursuant to N.C.G.S. §20-141(e), the Town can determine and declare speed limits for streets which are located within the Town limits which are not part of the State highway system; and

**WHEREAS**, the limits set pursuant to N.C.G.S. §20-141(e) become effective once appropriate signs giving notice thereof have been erected upon the part of the street affected; and

**WHEREAS**, the Town has determined and hereby declares that the following speed limits are reasonable and safe and should be adopted by the Town;


**NOW THEREFORE BE IT ORDAINED** by the Board of Commissioners of the Town of Pine Level the following speed limits upon the following streets which are not part of the State highway system:


