#### **4. STAFF UPDATE**

The board was updated on the actions taken by Town Council at the November Town Board meeting. Mr. Greg Johnson took his oath of office, his term is set to expire 10/31/2028

#### **5. OLD BUSINESS**

- **TABLED ITEM- UDO MODIFICATIONS**

Staff received feedback on the UDO (Unified Development Ordinance) from Merle Hall and Andrew Hodge and their thoughts on the proposed changes. Merle Hall explained to the Board he and Andrew Hodge looked over the proposed changes together and their collective ideas were presented to the Planning Board tonight. It was stated that the board members just received the feedback tonight and should take time to look over it.

#### **6. NEW BUSINESS**

- **Rezoning Request- Parcel #12N11011X**

The property owner is requesting the parcel currently zoned as RS (Residential Subdivision District) to RH (single and Multi-Family Residential District). There was discussion about the future land use plan and how it does away with RH. Chairman Kevin Kornegay stated that in the write up it stated that duplexes and multi family should be allowed in that district. Merle Hall spoke on behalf of Mrs. Renfrow, stated that they would like to have the option to do duplexes, townhomes or multi-family. Town Clerk, Ashley Willoughby, explained to the board that if they decided to recommend the rezoning, according to General Statues, there needs to be a statement of reasonableness or consistency statement due to the rezoning request going against the comprehensive land use plan.

**MOTION-** To recommend approval to the Town Board to change zoning from RS to RH on the property based on the future land use and its ability to be multi-family on that parcel. – Greg Johnson

- **2 Social District options to present to the Board**

Town Clerk, Ms. Ashley Willoughby presented the Board with a Social District Management Plan that can be customizable. Ms. Willoughby summarized the plan members received, and asked the Board members to contribute any ideas or changes that came to mind. There were concerns from members about the expense of this proposed Social District. Concerns about the expense for the trash cans and signs for the district were made. Ms. Willoughby stated that the Town Hall has a beautification fund that is dedicated towards right-of-way beautifications, flowers etc. The funds are for improving those areas. Mrs. Tonia Hill stated that the trash cans and signage is a one-time cost but recurring costs like insurance is the concern. The board agreed to take time to look over what has been presented.


## **7. DISCUSSION**

It was also mentioned that it will add more responsibilities to the town's police department as well.
