AGENDA AMENDMENT



DISCUSSION ON OFFICERS FOR 2022


Chairman Randy Jones said that the Planning Board has five In-town members and four ETJ members that can be elected as officers. The Planning Board also has three In-town Alternates that cannot hold office. He said that currently the Planning Board's Vice Chairman Kevin Kornegay is an In-town Alternate, however, he technically cannot serve as Vice Chairman while being an alternate. He continued to say that if anyone from the In-town members would like to step into the alternate position it would allow Kevin Kornegay to hold office as an In-Town member. After some discussion, Greg Johnson made a motion to hold officer elections either at the next meeting or the meeting in January 2022. Leighanna Worley seconded the motion and the vote passed unanimously.
