OATH OF OFFICE:

The Oath of Office was administered to Tammy Register by Administrative Assistant Ashley Willoughby.

MINUTES- NOVEMBER 18, 2021 -

Greg Johnson made a motion to approve the November minutes. Tammy Register seconded and the motion passed by unanimous vote.

ELECTION OF OFFICERS FOR 2022

Chairman Randy Jones stated that the Planning Board has five In-town members and four ETJ members that can be elected as officers. The Planning Board also has three In-town Alternates that cannot hold office. He said that currently the Planning Board's Vice Chairman Kevin Kornegay is an In-town Alternate, however, he technically cannot serve as Vice Chairman while being an alternate. He continued to say that if anyone from the In-town members would like to step into the alternate position it would allow Kevin Kornegay to hold office as an In-Town member. After some discussion, Randy Holloman made a motion to allow himself to step down from an In-Town member position into an In-Town Alternate position and for Kevin Kornegay to step up to the In-Town member position.


Motion was seconded by Trenton Broadwell and the vote was unanimous. Chairman Randy Jones said that Randy Holloman is now considered to be an In-Town Alternate and Kevin Kornegay is now an In-Town member. Trenton Broadwell made a motion to nominate Randy Jones for Chairman, Kevin Kornegay for Vice-Chairman, and Tonia Hill for Secretary of the Planning Board Committee. Randy Holloman seconded the motion; then made a motion to close and to approve the nominations. That motion was seconded by Faye Starling and passed by unanimous vote.

After some discussion, Chairman Randy Jones said that the board has a 2022 meeting schedule that needs a motion to approve. He continued by saying that the board meeting dates are still on the fourth Thursday of every month except for November and December due to them being so close to holidays. Tammy Register made a motion to approve the 2022 Planning Board meeting schedule. The motion was seconded by Trenton Broadwell and passed by unanimous vote.

MEETING ADJOURNED

There being no further business to discuss, Randy Holloman made a motion to adjourn. Greg Johnson seconded the motion. Motion passed by unanimous vote. The meeting adjourned at 7:35 p.m.
